21 On March 13, 2018, Magistrate Judge Honorable Donna M. Ryu issued an order for
22 Defendants to “show cause why Bian-wang.com is not subject to the requirements of Civil Local
23 Rule 3-9(b), which provides that “[a] corporation, unincorporated association, partnership or other
24 such entity may appear only through a member of the bar of this Court.” (Docket Item 17)

1 Miao's response on March 21, 2018 states that bian-wang.com "is a personal website" with
2 "no separate legal identity from Chun-hui Miao." Miao's conclusory response was not support by
3 a sworn declaration.

4 Plaintiff visited Bian-wang.com on March 22, 2018, and noticed a blog article at
5 <http://www.bian-wang.com/discuz/home.php?mod=space&uid=10003&do=blog&id=342> ,
6 published by Miao on April 2, 2014, and titled "The Pre-History, Present and Future of Bian-
7 Wang" (Chinese: 彼岸网的前世、今生和未来). In the article, Miao talked about how he and
8 LAO, aka, "lawandorder", allegedly a lawyer from New York, planned, designed and
9 collaborated over a period of many months to create Bian-Wang.com as a social networking
10 platform, with LAO offering legal consulting on the website and Miao handling other aspects.
11 When referring to Bian-Wang.com, Miao used the plural "We" (Chinese: 我们), instead of
12 singular "I" (Chinese: 我), in obvious reference to at least Miao himself and LAO, the alleged
13 New York lawyer.

14 Plaintiff would like to bring the above observation to the Court's attention.
